CASA staff will present your report to the Court. Your input is essential. Your child/children are counting on you to provide a voice in Court. Please review the schedule carefully. If you have any questions, contact any staff for assistance.

Foster Care Review

County Conferences are held every six months to discuss and review the permanent plan of the child/children in foster care. Your attendance and input is requested. The review is **NOT** a court hearing, however, the testimony delivered during the conference will be provided to the Court to aid in making decisions about the child's best interest. **Please contact the CASA staff if you are not able to attend.**

Latest Program Statistics

JC CASA is a volunteer–powered organization that advocates for the abused and neglected children of our county. We have an amazing group of dedicated volunteers that provide a voice for these children throughout their court process. As of February 28, 2021, **85 Volunteers** have served **141 children** from **78 families** with **515 donated hours of service for the 2020 calendar year.**

In-Service Dates for Volunteers

To maintain your CASA standing you are required to complete 12 hours of In-Service training each year. Be sure to include any completed In-Service hours on your monthly reports. We would like to discuss topics that would be beneficial to you. Please contact the CASA staff if you have special requests.

April 5, Jackson County Board of Supervisors will proclaim the month of April as National Child Abuse Prevention Month. The proclamation will be presented at their monthly meeting, held at the Jackson County Service Complex, 2915 Canty Street, Pascagoula. The meeting begins promptly at 9:00 a.m. in the Board Room, #2031. Representatives from CASA, CPS and the Youth Court will be there to accept the proclamation. Volunteers are invited to attend any of these meetings. Note: Moss Point's meeting will be virtual.

April 12, Angela Mallette, Director of Outreach of *End It for Good*, located in Jackson, will host two Zoom presentations titled "Understanding Childhood Trauma": presentation times are 2 and 6 p.m. This is a wonderful opportunity for volunteers and mentors to gain a deeper understanding of what the children we assist must deal with psychologically. Also, Ms. Mallette will provide the participants with tools to help our children in new and more concise ways. Seating is limited, so please make arrangements early if you plan to attend at the CASA building. *The Zoom link will be sent to you prior to April 12.*

April 26, Angela Mallette will host two Zoom presentations titled "Building Resilience". This will act as a building block on the first presentation, "Understanding Childhood Trauma". Also, it maybe standalone presentation that will strengthen our tool boxes with ways to help our children cope and move forward successfully. Seating is limited, so please make arrangements early if you plan to attend at the CASA building. There will also be an opportunity to attend virtually. *The Zoom link will be sent to you prior to April 26.*

April 12, 14, 20 and 27: Our spring Pre-Service Volunteer Training will be held throughout the month of April and conclude in early May. For a refresher on your advocacy for our children, volunteers may audit any or all of the training sessions. This will provide you with in-service hours. 
