Latest Program Statistics

JC CASA is a volunteer–powered organization that advocates for the abused and neglected children of our county. We have an amazing group of dedicated volunteers that provide a voice for these children throughout their court process. As of April 30, 2021, **89 Volunteers** have served **167 children** from **93 families** with **1613 donated hours of service for the 2021 calendar year.**

In-Service Dates for Volunteers

To maintain your CASA standing you are required to complete 12 hours of In-Service training each year. Be sure to include any completed In-Service hours on your monthly reports. We would like to discuss topics that would be beneficial to you. Please contact the CASA staff if you have special requests.

NETFLIX offers two movies that provide insight on some topics that affect many of our children and families. **You Are My Home** follows the relationship of a heartbroken woman and a young immigrant girl who has lost her mother at the border, coming together just before Christmas. **7 Yards: The Chris Norton Story** tells an inspiring story of Chris Norton's journey to overcome a traumatic event and rebuild his life. If you choose to view one or both of these movies, you must provide a very brief report to your supervisor. **Contact your supervisor to request the simple report form.**

Adopting Tiger, by Chavis Fisher is a book about a 12 year old foster child, Tiger, that two families are fighting to adopt. Tiger has a wish. But, is it heard or drowned by an imperfect system? It is in the Judge's hands. What will he decide? Where will be Tiger's forever home? We have 2 copies of the book in the CASA office. **Call your supervisor to reserve the book and they will let you know when it is available.** The book is available on Kindle (\$7.95) or in paperback (\$10.95 new) on Amazon. If you choose to read this book, you must provide a very brief report to your supervisor. **Contact your supervisor to request the simple report form.**

June 3, CASA will host an informative in-service regarding the services that Youth Villages provides for foster children. The presentation will be held at the Youth Court building at 3:00 p.m. Robin Sanford, Pre-Service Coordinator at Youth Villages in Biloxi will be the presenter. Robin will talk about MYPAC, assistance with transitional living and much more. **This is the first time that CASA has hosted Youth Villages. We are very excited to learn more about their program. This is an excellent opportunity for our volunteers.**
