CASA staff will present your report to the Court. **Your input is essential**. **Your child/children are counting on you to provide a voice in Court**. **Please review the schedule carefully**. **If you have any questions, contact any staff for assistance**.

Foster Care Review

County Conferences are held every six months to discuss and review the permanent plan of the child/children in foster care. Your attendance and input is requested. The review is **NOT** a court hearing, however, the testimony delivered during the conference will be provided to the Court to aid in making decisions about the child's best interest. **Please contact the CASA staff if you are not able to attend.**

August 3, 12:00 p.m. National CASA Association presents a Zoom webinar (Number 2 in a 3 part series), *Understanding the Indian Child Welfare Act (ICWA): Family, Community and Culture*. Participants will learn about the concepts and philosophical framework which undergird the ICWA and key requirements of the law and regulations that would be particularly relevant to CASA/GAL work. The webinar will provide strategies to keep children with parents and families, and connected with culture and community. August 24, 9:00—10:00 a.m. Angela Lynn, CASA Advocate Supervisor will host *Cares and Connection* at the Jackson County Civic Center, a round table discussion with volunteers. The meeting will allow volunteers an opportunity to meet and learn from other volunteers as they talk about any issues or concerns they may have regarding cases. Also, the meeting will allow the staff an opportunity to highlight and praise our outstanding volunteers.

Numerous research studies have informed us that there is a correlation between legal or illegal substance misuse and violence/domestic violence in the home. Often, one of these is missed when we are working with children and families...one of the reasons families have high recidivism rates. This one-hour presentation will take a look at both legal and illegal substance misuse and domestic violence individually, how they impact the family unit, and then discuss their intersection in order to provide a larger picture of the combined impacts. Participants will gain an increased knowledge of how legal and illegal substance misuse and domestic violence impact children and families. They will also gain a better understanding of their impacts on children and families. The webinar will be presented by National Alliance for Drug Endangered Children. 
