# **City Proclamations**

In 1983, by presidential proclamation of then President Ronald Reagan, April was declared National Child Abuse Prevention Month. Every year since, the President rededicated the month with a new proclamation. Many state governors and local governing bodies also issue proclamations to encourage public awareness, as well as recommit resources, to the cause and promote community involvement through state and local activities.

Jackson County CASA, Inc. received overwhelming support for the CASA mission this year from Jackson and George Counties. April 5, at their monthly meetings, each county proclaimed April as Child Abuse Awareness and Prevention Month. The cities of Gautier, Moss Point, Ocean Springs, and Pascagoula followed suite at their monthly meetings as they also recognized April as Child Abuse Awareness and Prevention month. Representatives of the CASA governing board and staff and Child Protection Services (CPS) staff members attended each meeting to accept the proclamation and discuss the importance of community support in fighting for the protection of the most vulnerable citizens. It is an honor to provide advocacy for the abused and neglected children of these local communities. We are grateful to have their support of the mission. The proclamations are proudly on display in the CASA office as a reminder of the local communities continued support.

During April, people across the country come together to raise awareness of child abuse and neglect prevention. You continue to make a difference year round through the donation of your time as a CASA advocate.

To say that it has been an honor to have served in this position for almost 20 years would be an understatement. My life has been truly blessed by the opportunity to make a difference in the lives of children and families in Jackson County. I will retire knowing that I have done my best. Even when I made mistakes, I took that opportunity to learn from my mistakes. I have enjoyed watching our CASA program grow under the leadership of Frances Allsup from a mere four volunteers serving 11 children in 2006 to over 100 volunteers today serving 217 children in the calendar year 2021. I have personally seen the difference a CASA volunteer makes in the lives of the children they touch. I will be forever grateful for the honor of working so closely with such a wonderful group of dedicated community volunteers.

# 2022 CASA Blues CHAMPION FOR CHILDREN

Angel Myers McIlrath was selected this year's *Champion for Children*. Angel is serving as the District Attorney for the 19th Circuit Court District, serving the citizens of Jackson, George, and Green Counties.

As a member of the Mississippi Prosecutors Association Board of Directors and Legislative Committee, she has been integral in drafting and lobbying for MPA sponsored legislation, including the Lonnie Smith Act, which amended the child abuse laws to better protect children, and a number of other laws making our community safer.

Angel also teaches law enforcement, attorneys, and medical professionals on various subjects concerning physical and sexual abuse of children, exploitation of children, and best practices in criminal investigations.

Without a doubt, she is a true Champion for Children.

## **TBRI® Practitioner Training**

Congratulations to Angela Lynn, JC CASA Advocate Supervisor, who has been accepted to the TCU / Karyn Purvis Institute for Trust-Based Relational Intervention (TBRI®) Practitioner training. Angela applied for and received two scholarships to cover the cost of the training, one from *Show Hope* and the other from Hancock and Harrison Counties judicial system. Hancock and Harrison Counties, with grant funding, is offering this training program to individuals along the gulf coast to receive TBRI® training.



TBRI® is an attachment-based, trauma-informed intervention that is designed to meet the complex needs of vulnerable children. TBRI® uses *Empowering Principles* to address physical needs, Connecting Principles for attachment needs, and *Correcting Principles* to disarm fear-based behaviors. While the intervention is based on years of attachment, sensory processing, and neuroscience research, the heartbeat of TBRI® is connection.

Angela will start her 10 weeks of online training in April, followed by a week of in person training in Biloxi. Upon successfully completing the training, she will become a <u>certified TBRI® Practitioner</u>, allowing her to train our staff and volunteers, foster parents, and others in the child's support system.
