We are so excited to announce that Jackson County CASA was selected to receive a Charitable Giving Fund Donation from Sparklight for \$2,500! The check was presented by Greg Capranica and Leah Singleton to Executive Director, Frances Allsup, and the CASA governing board members at their June 22 monthly meeting. This grant money will be used to purchase some much needed equipment – 4 Microsoft Surface Go 3 tablets, hardcover keyboards and a stylus for each. These tablets will allow advocate supervisors to work remotely and transfer critical records in an instant! June 16, CASA hosted an informative continuing education opportunity regarding mental health issues in youngsters. The presenter was Donna Lewis, a licensed counselor, who has over 25 years of experience as a clinical social worker and therapist specializing in providing resources and assisting individuals heal from trauma, PTSD, and dissociative, attachment, and borderline personality disorders. Donna talked with volunteers and staff about some of the issues that affect the children in foster care and provided some practical tools and resources to help volunteers, parents, and foster parents develop a better understanding of how some children deal with their emotions in different situations. The Q and A that followed will potentially lead to a follow-up session for individual case-related questions. We are especially grateful to Gulfport Behavioral, and our amazing CASA advocate Michelle Wilson, for providing the delicious pizza, cookies, and cold drinks.

On June 23, John Harry with Hope Rising Mississippi, a non-profit organization, presented a continuing education program for staff, volunteers, board members, and service providers focusing on *Hope against Adversity* and how instilling hope can change the trajectory of a child's life. John has extensive experience in working with the youth court process and foster children. The power point presentation was geared toward working with children and families who have been exposed to domestic violence and trauma, and how these factors can affect overall behavior and personality. He targeted working with clients to set real, attainable goals (both short and long term), helping them develop pathways (ways to get to this goal), and agency (making informed choices to help them achieve this goal). He presented a wealth of information about the effects and long-term consequences of ACE's (adverse childhood experiences) and the process of generalization. The closing small group activity focused on the role a CASA plays in the process by offering concrete suggestions on what caring adults can do to support their clients and the importance of communicating with a common voice and developing a simultaneous relationship with all involved (the court, CPS, associated parties, etc.).

As of May 30, 2022, **104 Volunteers** have served **168 children** from **106 families** with **1,831 donated hours of service during the 2022 calendar year.**

Continuing Education Opportunities

Reminder— to maintain your CASA standing, you are required to complete 12 hours of Continuing Education training each year. Be sure to include any completed Continuing Education hours on your monthly activity reports that are submitted in OPTIMA. We would like to add additional topics that would be beneficial to you as a volunteer. Please contact the CASA staff if you have special requests.

On July 11 from 9 – 11 am and from 2 – 4 pm, the program will host two *CASA Cares* continuing education opportunities. This roundtable discussion provides a chance for volunteers, staff, and service providers to it down together and discuss in a safe environment the good and the bad situations and issues going on with individual cases. This month's special guest speaker will be Katy Frazier. Katy started out her career as a frontline worker with CPS. She has been a supervisor, heads up the Heartbeat Program for children ages 4 and under, and currently serves as the permanency coordinator and intake officer for the Jackson County Youth Court. With her wealth of knowledge, she will be able to answer questions and provide valuable information from her unique perspective. If you are new to CASA or do not currently have a case, please make plans to attend to learn more about how the volunteer's role is critical in creating a positive outcome for each child and family involved in the youth court system. Both sessions will be held at the Jackson County Civic Center on Shortcut Road in Pascagoula. Book Selection for the month: *Halfway Home: Race, Punishment, and the Afterlife of Mass Incarceration* by Dr. Reuben Jonathan Miller

Each year more than half a million Americans are released from prison and join a population of twenty million people who live with a felony record. Dr. Miller, a chaplain at the Cook County Jail in Chicago and now a sociologist studying mass incarceration, spent years alongside prisoners, ex-prisoners, their friends and their families to understand the lifelong burden that even a single arrest can entail. What his work revealed is a simple, if overlooked truth: life after incarceration is its own form of prison. The idea that one can serve their time and return to their family and life as a full-fledged member of society is one of America's most shocking myths. Recently released individuals are faced with jobs that are off limits, apartments that cannot be occupied, and votes that cannot be cast. It pinpoints that the American justice system was not created to rehabilitate individuals. Parole is also structured to keep many individuals impoverished, unstable, and disenfranchised long after they have paid their debt to society. Dr. Miller combines persuasive data with clear prose, close engagement with his interview subjects, and stories from his own personal experience into a compelling blend that will easily keep readers absorbed. His findings are instructive and emotional without being too scholarly.

Your Court date is **very important.** Your **presence is needed** at all Court hearings. However, if you are unavailable to attend, please contact the CASA office and provide an update of your case. CASA staff will present your report to the Court. **Your input is essential**. **Your child/children are counting on you to provide their voice in Court**. **Please review the schedule carefully. If you have any questions contact any staff for assistance**.

Foster Care Review Schedule

A Foster Care Reviews (aka County Conference) is held every six months to discuss and review the permanent plan of the child/children's in foster care. Your attendance and input is requested. The review is **NOT** a court hearing, however, the testimony delivered during the review will be provided to the Court to aid in making decisions about the child/children's best interests. **Please contact the CASA staff if you are not able to attend.**
