These monthly sessions are planned to help volunteers earn the annual required 12 CE hours. See the flyer on page 4 for information on the next opportunity to help volunteers, staff, and foster parents learn more about their students' individual education plans.

Patrick Brandle** with the **Pascagoula Police Department**. A career officer, **Capt. Brandle** discussed with participants his first-hand knowledge of the many aspects involved in human trafficking. He presented practical advice on what volunteers can do to assist current victims and suggested practical steps that families can take to prevent more youth from becoming victims of human trafficking. He also shared information on a new local program being instituted in Pascagoula to pair officer volunteers with teens in an effort to better establish positive relationships between the groups within the local community. The session closed with time for individual questions to be answered.

She provided information on the upcoming *College Tour* to be held from 2-4 pm on March 28 at the MS Gulf Coast Community College Jackson County Campus where youth in foster care ages 16 and up will be able to learn about the different Career and Technical Pathways & Programs. Other volunteers joining the presentation online were **Laura Hasty** and **Teresa Tanner**. **Amber Ehlers** attended and volunteered to act as photographer for the group photo.

Jeremy Moore gave a very broad overview of Youth Transitional Services available to older youth in CPS custody. This might include doing annual credit reports, helping them receive various types of financial aid to help with college scholarships and housing, assisting them with financial management and transportation, and connecting them with local job programs such as Job Corps. It is truly important to learn how much assistance is available to help with education, housing, and insurance needs for older youth who are aging out of foster care. Both presenters stressed the need for concerned adults to listen to and communicate with our older youth.
